

CITY OF SOUTH TUCSON ORDINANCE NO. 08-02

AN ORDINANCE OF THE CITY OF SOUTH TUCSON, ARIZONA, RELATING TO THE PRIVILEGE LICENSE TAX; ADOPTING "THE 2008 AMENDMENTS TO THE TAX CODE OF THE CITY OF SOUTH TUCSON" BY REFERENCE; ESTABLISHING AN EFFECTIVE DATE; PROVIDING FOR SEVERABILITY AND PROVIDING PENALTIES FOR VIOLATION

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, AS FOLLOWS:

Section 1. That certain document known as "The 2008 Amendments to the Tax Code of the City of South Tucson," three copies of which are on file in the office of the City Clerk of the City of South Tucson, Arizona, which document was made a public record by Resolution No. 08-21 of the City of South Tucson, Arizona, is hereby referred to, adopted and made a part hereof as if fully set out in this Ordinance.

Section 2. That any person found guilty of violating any provision of these amendments to the tax code shall be guilty of a class one misdemeanor. Each day that a violation continues shall be a separate offense punishable as herein above described.


Section 3. That if any section, subsection, sentence, clause, phrase or portion of this Ordinance or any part of these amendments to the tax code adopted herein by reference is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.

Section 4. That the provisions of sections 1 through 3 of this Ordinance shall be effective from and after July 1, 2008.



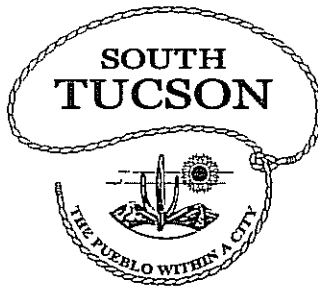


CITY OF SOUTH TUCSON RESOLUTION NO. 08-21

BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA:


