

CITY OF SOUTH TUCSON ORDINANCE: 13-06

ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, APPROVING AND ADOPTING REVISIONS TO THE SOUTH TUCSON CITY CODE ON ENFORCEMENT AT ARTICLE I, CHAPTER 3-1: ANIMALS AND FOWL, AND AUTHORIZING THE MAYOR TO EXECUTE THIS ORDINANCE FOR THE PURPOSE OF EMPOWERING PIMA COUNTY ANIMAL CONTROL PURSUANT TO THE NOW EXISTING INTERGOVERNMENTAL AGREEMENT "IGA."

WHEREAS, the City of South Tucson Mayor and Council is required to review and approve the Revisions to the City of South Tucson City Code; and

WHEREAS, the City of South Tucson has entered into an intergovernmental agreement "IGA" with Pima County Animal Control for a two-year period beginning July 1, 2012 and ending June 20, 2014 to carry out the enforcement provisions of this Chapter related to Animals and Fowl; and

WHEREAS, the Mayor and Council of the City of South Tucson have determined that it is in the best interest of the City and its residents to approve and adopt Enforcement Revisions to Chapter Three; and

WHEREAS, the Mayor and Council of the City of South Tucson desire to have this item presented at its October 30, 2013 Council Meeting; and

BE IT RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that the City hereby formally approves and adopts the Chapter Three (3), Article I, Section 3-1 under the attached Chapters as presented.

ARTICLE I. IN GENERAL

Sec. 301. Enforcement

Any peace officer, or county animal control officer is hereby authorized and empowered to enforce all provisions of this chapter, *EXCLUDING SECTION 3-3*, *PARAGRAPH 3; THE PROVISION PROHIBITING THE ADMINISTRATION OF ANABOLIC STEROIDS TO GREYHOUND DOGS, WHICH IS STRICTLY GOVERNED BY STATE LAW UNDER ARIZONA ADMINISTRATIVE CODE;* and to issue citations for violations thereof in accordance with the intergovernmental agreement "IGA" with Pima County Animal Control adopted pursuant to Ord. No. 13-06 on 10/30/13

BE IT FURTHER RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that, due to an existing emergency declared herein, the immediate effectiveness of this Ordinance is necessary to preserve the peace, health, and safety of the City of South Tucson, Arizona, and this Resolution shall therefore be effective upon its passage and adoption.
